The Governor has been pleased, in the interest of the Public Service, to appoint the following 2(two) candidates, whose position in order of merit is noted against each of their names, to the WBCS (Exe) and post them temporarily as Deputy Magistrate & Deputy Collector (on probation) in the revised Pay Band (PB-4A), Scale of pay of Rs.15600 - 42000/- with Grade Pay of Rs.5400/- [Pay including Grade Pay at entry level is Rs.21000/- under the WBS (ROPA) Rules, 2009] plus other allowances as admissible from time to time under the orders of Government, with effect from their dates of joining and until further orders.

The appointment has been made on the basis of the results of the West Bengal Civil Service (Executive) etc. Examination, 2014 - Group 'A' Services, conducted by the Public Service Commission, West Bengal and recommended for appointment vide their Memo No.A-22-P.S.C.(A) dated 29.01.2016.

Medical certificates of fitness in the prescribed form in respect of the concerned candidates have been obtained as required in terms of Sub-Clause (1) of Note 3 below Rule 11 of the West Bengal Service Rules, Part-I. The Police Verification Reports in respect of the candidates concerned have also been obtained. Both the Reports are found to be satisfactory:-

All the officers, appointed to the WBCS (Exe) Cadre have to join as Deputy Magistrate & Deputy Collector (on probation) in the P & AR Department, Nabanna, 7th Floor (Room No.705), 325, Sarat Chatterjee Road, Howrah-711102 immediately.

All the officers will be on probation for a period of 2 (two) years with effect from the dates of their joining in the aforesaid service. During the period of probation, they will be required to undergo the Training prescribed for the officers of the WBCS (Exe) Cadre and to pass the Half Yearly Departmental Examination completely as prescribed in the relevant provisions of the West Bengal Services (Training and Examination) Rules. Their confirmation will depend on passing the Half Yearly Departmental Examination completely, submission and acceptance of case records, required Treasury Training and subject to fulfillment of other conditions as are required for confirmation. In case, they fail to fulfill the conditions for confirmation as aforesaid or if they are otherwise found unsuitable for the said service, they will be liable to be discharged from the service during or at the end of the period of probation.


