
I am directed to address you on the subject noted above and to state that the next Half-yearly Proficiency Test in Regional (Bengali) Language for officers of the All India Services serving under the Government of West Bengal, is scheduled to be held on the 29th January, 2026 in the **Examination Hall** of the Commission at 161A, S. P. Mukherjee Road, Kolkata-700 026. In this connection detailed particulars of the test as laid down in chapter IX of the Services (Training and Examination) Rules, West Bengal is enclosed for your perusal. A copy of the notification No. 116- P.S.C.(I/Dept'l.) dated the 19th December, 2025 sent for publication in the **Kolkata Gazette (extraordinary)** on the 26th December, 2025 is also enclosed.

The officers of the All India Services serving under the Government of West Bengal, whose mother tongue is not Bengali and who have joined the state service within the last five years, are eligible to appear at the said test. I am directed to request you to kindly issue suitable instruction upon the concerned authorities to forward the names of eligible officers who desire to appear at the said test to this office on or before the 15th January, 2026. It may be noted that names received thereafter will not be entertained by the Commission for the test. The officers desirous of attending the said test will apply through proper channel for permission as mentioned in Service (T & E) Rules, W.B., in the prescribed form of application as annexed herewith.

Applications sent by the officers directly to the Commission will not be entertained.

An acknowledgement of receipt of the letter with its enclosure is earnestly solicited.

Standard of qualification—Sixty per cent of the total marks in each of Part I and Part II will be the pass mark.

The Secretary to the Board of Examiners (Army Department), Delhi, and Simla, will conduct the examinations in Khaskura or Gurkhali during the Board's bi-annual visits to Calcutta in March or April and in October or November each year and will arrange for the conduct of examinations in Lushai, Garo, Kachari or Mech at selected stations in Assam as the need arises.

Officers desirous of attending these examinations should apply for permission to the Chief Secretary to the Government of West Bengal through the Inspector-General of Police, West Bengal.

The Secretary to the Board of Examiners will notify to intending candidates the exact date and place of the examinations and will report to the State Government the names of officers who have passed and are entitled to the prescribed rewards.

CHAPTER VIII

Rules regarding the Training and Examination of temporary officers whether Gazetted or Non-Gazetted (vide Notification No. 10518-F., dated 4th December 1974) appointed in different categories under the State Government

1. Unless otherwise specifically stated in Chapter II(B) of the rules the temporary officers holding appointments, which are likely to continue for more than five years, shall have to pass the departmental examination and undergo the requisite training as prescribed for the probationers of the corresponding permanent categories within two years from the dates of their appointments. The temporary officers holding such appointments as are not likely to continue for more than five years, shall, however, have to pass the departmental examination in (Accounts) only as prescribed for the probationers of the corresponding categories within one year from the dates of their appointments.

2. Those temporary officers who are already in service shall be liable to pass the examination of the respective categories within the stipulated period from the date of publication of these rules.

3. The Administrative Department concerned shall communicate to the Public Service Commission, West Bengal, the nature of appointment of an Officer and the period for which he is likely to continue in the temporary post held by him. If the tenure of appointment, initially deemed to continue for a period not exceeding five years, is finally found to continue for more than five years the commission should be immediately apprised of the position.

4. Those who are first made liable to pass the departmental examination at the age of 50 or above shall not be required to pass the examination.

5. The appointing authority may, however, extend the time limit for passing the examination by a further period not exceeding half the prescribed period on reasonable grounds to be recorded in writing. Failure to pass the examination even within the extended period shall make them liable to be discharged unless otherwise decided by Government.

6. In case a temporary officer fails to pass the departmental examination completely within the stipulated period his future increments shall be withheld until he passes the examination completely and on passing the examination at a subsequent date he shall draw from the date of passing the examination the pay he would have drawn had he passed the examination within the stipulated period.

CHAPTER IX

Rules regarding the grant of monetary award to the Officers of the All India Services who attain proficiency in Regional (Bengali) Language

A lump award of Rs. 1000 (Rupees one thousand) will be given to those All India Services Officers, whose mother tongue is not Bengali and who will attain a fairly higher proficiency in that language by passing a special examination in Bengali in the standard prescribed below, within a period of five years after the date on which they joined the State Government.

Rules regarding Examination in Regional (Bengali) language

) The Examination will be more or less equivalent to that of the first language (Bengali) of the Yamik Examination of the Board of Secondary Education, West Bengal and will be held in two parts, Part-I Written, Part-II-Oral, according to syllabus detailed below. No. book is prescribed for the nation.

Syllabus for the Regional (Bengali) Language Examination

Part I—Written Paper. Time—3 Hours

Details of Subjects	Full Marks
a) Translation from English into Bengali	20
b) Translation from Bengali into English	20
c) Essay Writing	30
d) Letter Writing/Dialogue	15
e) Precis/Substance	15
Total ...	<u>100</u>

Part II—Oral

Details of Subject	Full Marks
a) Conversation in Bengali on topics of general interest and matters connected with official duties of candidates	30
b) Reading of petitions, letters etc. (Manuscript)	20
Total ...	<u>50</u>

(ii) Standard of qualification: In order to qualify at the examination, a candidate will be required to pass in both the parts in the same examination. Sixty per cent of the total marks in each of Part-I and Part-II of the examination will be the pass marks.

3. The Examination will be held by the Public Service Commission, West Bengal, in May and November every year along the Half-yearly Departmental Examination of Probationary Officers in Calcutta.

4. The officers desirous of attending the examination should apply for permission to the Chief Secretary through proper channel in prescribed application form (enclosed). The application should reach Government at least two months before the date of the examination which will be announced by the Public Service Commission, West Bengal, in the Calcutta Gazette. The Government will thereafter forward the list of eligible candidates to the aforesaid Commission at least one month before the date of the examination.
