On page 2 of the original Notice Inviting e-Tender No. :WBSSC/SEC/NIEt-01(e) /2025-26, in the lines 1 and 2 of the paragraph (i) under the Point No. 7, viz., **General Terms & Conditions of Bid**, for the figure of “**Rs. 89,918.00/-**” and for the words “**Rupees eighty nine thousand nine hundred and eighteen**” the figure of “**Rs. 80,000.00**” and the words “**Rupees Eighty thousand**” shall be substituted respectively.
