All the officers, appointed to the WBCS(Exe.) Cadre will join as OSD in P & AR Department within 10 days from the date of issuing this order. Their service in the WBCS(Exe.) Cadre will be counted w.e.f. the date of their joining in the said service.

All the officers will be on probation for a period of 2 (two) years with effect from the date of their joining in the service. Their confirmation will depend on their satisfactory services and on passing the Half-yearly Departmental Examination, prescribed for the promote officers, in terms of the relevant provisions in the W.B.C.S (Training and Examination) Rules. In the event, if they are considered to be unsuitable for the service, they will be liable to reversion to their respective feeder posts during the end of the period of their probation.

The Department of P & RD is requested to make arrangements for release of the concerned officers, appointed as OSD, hereinabove, in order to enable them to join as OSD in P & AR Department within 10 days from the date of issuing this order.
