

- iii) Submission of application (online): From 24/03/2026 (10:00 hrs) to 08/05/2026 (17:00 hrs).
- iv) The attested application of IAS, IFS and WBCS(Exe) officer's is to be uploaded to application portal using "Upload Attested Application" button within the last date of application.
- v) Identification Certificate of eligible candidates with Roll Numbers can be downloaded from the online application portal from 12/05/2026 at 15:00 hrs, after login to respective user id.
- vi) Attestation of the photo and signature of the applicant should be done by his/ her immediate Controlling Officer/ Head of Office/ Competent Authority.
- vii) The applicant is advised to bring his/her service identity cards along with Identification Certificate at the examination centre for proper identification.
- viii) No electronic gadgets such as Smart Phone/ Smart Watch/Laptop/Tablet etc. will be allowed in the examination hall.
- ix) Examinees in subjects with books should bring their own copies for consultation at the examination hall. They will be permitted to consult only unannotated editions of acts, regulation and codes etc. during the examination.
- x) No TA/ DA will be admissible.

- vii) Generate Identification Certificate on or after 12/05/2026 at 15:00 hrs.


