ORDER

Smt. Debika Karmakar, D/O- Shri Trilochan Karmakar, Vill- Jadabganj, P.O.- Fulberia, P.S.- Garhbeta, Distt.- Paschim Medinipur, PIN – 721127 being Date of Birth on 8th March, 1992 was recommended for appointment to the post of Lower Division Assistant under Secretariat Common Cadre on the basis of the results of Clerkship Examination, 2019 conducted by the Public Service Commission, West Bengal.

Smt. Debika Karmakar was declared 'unfit' in the Medical Examination Report vide memo no. 294/M.B. dt. 16.02.2023, furnished by Medical Board constituted by the Directorate of Health Services.

Smt. Karmakar challenged the Medical Examination Report before the Hon'ble High Court, Calcutta. The Hon'ble Court has directed to proceed to offer appointment letter to the petitioner vide order dated 29.07.2025, Sl. No. 134 (WP.ST 130 of 2025).

As directed by the Hon'ble High Court, Calcutta, Medical Examination was arranged for second time by the Directorate of Health Services and Smt. Karmakar has been declared fit by the Medical Board as per honourable court order.

After successful completion of the appointment process including Document Verification, Smt. Debika Karmakar, D/O- Shri Trilochan Karmakar is hereby appointed, on temporary basis, to the Secretariat Common Cadre of Lower Division Assistants in the Finance Department, on the basis of recommendation of PSC, WB, as per Clerkship Examination, 2019, conducted by the Public Service Commission, West Bengal, in the Level-6 (₹22,700/- – ₹58,500) under the pay structure of W.B.S. (ROPA) Rules, 2019 plus allowances as admissible from time to time under the rules with effect from the date of joining the post and until further order(s) and the seniority of Smt. Debika Karmakar, in the post of Lower Division Assistant, will be determined later.
