WHEREAS the erstwhile offices of the District Magistrate, Burdwan, Sub-Divisional Officers and Block Development Officers within the local limits of Purba Bardhaman district along with the other Officers of the P&AR & e- Gov. Department posted therein have been redefined in the new District of Purba Bardhaman and;

WHEREAS the erstwhile Offices of the Sub-Divisional Officers and Block Development Officers within the local limits of Paschim Bardhaman District along with other officers of the P&AR & e-Gov. Department posted therein have been redefined in the new District of Paschim Bardhaman.

NOW THEREFORE, the Government is pleased hereby to rename and redesignate the District Magistrate, Burdwan as the District Magistrate, Purba Bardhaman, Additional District Magistrate as the Additional District Magistrate, Purba Bardhaman and so on in case of other Offices and posts. Similarly, those Offices and posts under the new District of Paschim Bardhaman are to be renamed *mutatis mutandis*.
